

MWBC Award Nomination Criteria for: WOMAN RISING STAR OF THE YEAR



What are the evaluation/selection criteria for the Woman Rising Star of the Year Award?

In evaluating the nomination packages, the judges will look at the following criteria. Be sure to address each section in the nomination package.

- 1. Must be a women entrepreneur who owns and operates a for-profit, small business that has been in operation for less than three years.
- 2. Demonstrated business performance, growth and economic impact through sales increase, jobs created and/or capital infusion within one to two years of business.
- 3. Demonstrated potential to be a role model in her business or sectoc, and is recogized by others as having the potential to become a future leader in her industry.
- 4. Demonstrated commitment to community involvement.
- 5. Challenges and adversities the nominee has overcome.

What is the nomination package deadline?

All nomination packages must be received **no later than 3:00 p.m. (ET) on August 30, 2019**.

How should I submit the nomination package?

Nomination packages may be submitted online or via physical hardcopy.

Online nomination packages should be submitted by the deadline using the Woman Rising Star of the Year form, which can be found at: http://rockvilleredi.org/news-events/mwbc-nominations-5.

Hardcopy nomination packages should be submitted by the deadline (postmarked or hand delivered) to: Maryland Women's Business Center 51 Monroe Street, PE-20, Rockville, MD 20850.

What information must the nomination package contain?

Nominations must contain the information required below. *Incomplete nomination packages will not be considered.*

NOTE: The online nomination form will prompt you for all of the required information listed below.

- Complete Nominee and Nominator information, including Nominee's award category, full name, business name, telephone number, email address AND Nominator's full name, telephone number and email address.
- 2. Documents specifically addressing ALL of the evaluation/selection criteria.
- 3. An original 8" x 10" or 5" x 7" headshot of the nominee or a digital photo at least 300 dpi is required; photocopies are not accepted.
- 4. Additional supporting documentation deemed significant by the nominator, including biography, news clips, letters of recommendation, nomination letter (if not self-nominated) and other evidence of the appropriateness of the nomination. Videos will not be considered.

Nomination packages must not exceed 10 pages, including supporting documentation.
